Specific Program Objectives:

- Master Scripture relevant to church and leadership development, particularly through study of the biblical theology of Acts and the Pauline Epistles.
- Reflect on the contributions of leading scholars regarding church and leadership development.
- Address the pertinent issues related to church and leadership development and analyze Scripture and other contributions related to those issues.
- Formulate conclusions and personal applications regarding those issues.
- Obtain advanced mastery through substantial implementation in real ministry situations and careful evaluative reflection on that implementation. The emphasis on learning through real ministry situations is a major distinctive between the B.Min. and the M.Min

Master's Course Requirements:

- Master's students are held to a very high level of academic rigor and production.
- Master's are required to complete all reading reports, *all* course projects (more than the bachelor's programme projects), "great book" synopsis, the oral exam, and the summary project (term paper).¹
- An emphasis on learning through real ministry situations is a major distinctive between the B.Min. and the M.Min
